I am pleased to announce that a total of \$529,295 for the FY22 GAINS Program Round 2 has been provided to Hamilton-Ryker from June 30, 2022 through December 31, 2023. The enclosed Notice of Award (NOA) reflects the allocation of these funds.

The purpose of the GAINS program is to promote the expansion and development of United States Department of Labor (USDOL) approved programs that drive economic development through skills and educational attainment. The GAINS program aims to integrate the apprenticeship training model into non-traditional occupational sectors in an effort to create more sustainable career pathways that lead to better-paying jobs and advanced credentials for New Jersey Residents.

The contract length for this grant is 18-months, during which your organization will be expected to receive approval for your program from USDOL and register program apprentices. Monthly reports will also be required for submission to NJDOL, that outline activities and expenses, with the expectation that all funds be expended by the end of the contract period.
